

QUANTUM PHYSICS SLIT EXPERIMENT

UNDERSTANDING THE DOUBLE-SLIT EXPERIMENT

AT ITS CORE, THE QUANTUM PHYSICS SLIT EXPERIMENT, MOST FAMOUSLY THE DOUBLE-SLIT EXPERIMENT, IS DESIGNED TO PROBE THE FUNDAMENTAL NATURE OF MATTER AND ENERGY. IT ASKS A SEEMINGLY SIMPLE QUESTION: WHEN WE SEND PARTICLES THROUGH A BARRIER WITH TWO NARROW OPENINGS, WHAT PATTERN DO WE OBSERVE ON A SCREEN BEHIND IT? THE ANSWER, AS DISCOVERED AND ELABORATED UPON THROUGH DECADES OF SCIENTIFIC INQUIRY, IS ANYTHING BUT SIMPLE, REVEALING THE ENIGMATIC PROPERTIES OF THE QUANTUM REALM.

HISTORICAL CONTEXT AND EARLY DISCOVERIES

THE ROOTS OF THE DOUBLE-SLIT EXPERIMENT CAN BE TRACED BACK TO THE EARLY 19TH CENTURY WITH THOMAS YOUNG'S GROUNDBREAKING WORK ON LIGHT. AT A TIME WHEN LIGHT WAS LARGELY CONSIDERED TO BE A STREAM OF PARTICLES (CORPUSCULAR THEORY), YOUNG PERFORMED A SIMPLE YET REVOLUTIONARY EXPERIMENT USING SUNLIGHT AND A CARD WITH TWO CLOSELY SPACED SLITS. HE OBSERVED THAT INSTEAD OF TWO BRIGHT LINES ON A SCREEN OPPOSITE THE SLITS, HE SAW A PATTERN OF ALTERNATING BRIGHT AND DARK BANDS – AN INTERFERENCE PATTERN. THIS PATTERN IS A HALLMARK OF WAVE BEHAVIOR, WHERE CRESTS AND TROUGHS OF WAVES CONSTRUCTIVELY AND DESTRUCTIVELY INTERFERE WITH EACH OTHER. YOUNG'S EXPERIMENT PROVIDED STRONG EVIDENCE THAT LIGHT BEHAVES AS A WAVE.

HOWEVER, THE STORY DIDN'T END THERE. AS THE 20TH CENTURY DAWNED, ADVANCEMENTS IN PHYSICS LED TO THE DEVELOPMENT OF QUANTUM THEORY, AND WITH IT, A RENEWED DEBATE ABOUT THE NATURE OF LIGHT AND MATTER. EXPERIMENTS LIKE THE PHOTOELECTRIC EFFECT, EXPLAINED BY ALBERT EINSTEIN, DEMONSTRATED THAT LIGHT ALSO EXHIBITS PARTICLE-LIKE PROPERTIES, BEHAVING AS DISCRETE PACKETS OF ENERGY CALLED PHOTONS. THIS LED TO THE REVOLUTIONARY CONCEPT OF WAVE-PARTICLE DUALITY, SUGGESTING THAT ENTITIES LIKE LIGHT POSSESS CHARACTERISTICS OF BOTH WAVES AND PARTICLES, DEPENDING ON HOW THEY ARE OBSERVED OR MEASURED.

THE BASIC SETUP: PARTICLES AND WAVES

THE CLASSIC DOUBLE-SLIT EXPERIMENT INVOLVES A SOURCE THAT EMITS PARTICLES (OR PHOTONS), A BARRIER WITH TWO

PARALLEL SLITS, AND A DETECTION SCREEN PLACED BEHIND THE BARRIER. WHEN THE EXPERIMENT IS CONDUCTED WITH CLASSICAL OBJECTS, LIKE MARBLES OR EVEN LARGER PARTICLES, WE EXPECT A STRAIGHTFORWARD RESULT. IF WE FIRE MARBLES THROUGH THE TWO SLITS, WE WOULD OBSERVE TWO DISTINCT PILES OF MARBLES ON THE DETECTION SCREEN, DIRECTLY ALIGNED WITH THE OPENINGS. THIS IS INTUITIVE AND ALIGNS WITH OUR EVERYDAY UNDERSTANDING OF HOW SOLID OBJECTS BEHAVE.

WHEN THE EXPERIMENT IS PERFORMED WITH QUANTUM ENTITIES, SUCH AS ELECTRONS, PHOTONS, OR EVEN ATOMS, THE RESULTS BECOME ASTONISHINGLY DIFFERENT. INSTEAD OF TWO DISTINCT BANDS, AN INTERFERENCE PATTERN EMERGES ON THE DETECTION SCREEN, MIRRORING THE PATTERN OBSERVED WITH WAVES. THIS IMPLIES THAT THE PARTICLES, DESPITE BEING FIRED INDIVIDUALLY, ARE SOMEHOW PASSING THROUGH BOTH SLITS SIMULTANEOUSLY AND INTERFERING WITH THEMSELVES. THIS WAVE-LIKE BEHAVIOR WHEN UNOBSERVED IS A FUNDAMENTAL CHARACTERISTIC OF QUANTUM MECHANICS, ILLUSTRATING THAT AT THE SUBATOMIC LEVEL, THE LINES BETWEEN WAVE AND PARTICLE BLUR.

WAVE-PARTICLE DUALITY EXPLAINED

WAVE-PARTICLE DUALITY IS PERHAPS THE MOST COUNTERINTUITIVE CONCEPT TO ARISE FROM THE QUANTUM PHYSICS SLIT EXPERIMENT. IT POSITS THAT QUANTUM OBJECTS, LIKE ELECTRONS OR PHOTONS, DO NOT EXCLUSIVELY BEHAVE AS WAVES OR PARTICLES. INSTEAD, THEY EXHIBIT PROPERTIES OF BOTH. WHEN WE ARE NOT ACTIVELY MEASURING OR OBSERVING THEIR PATH, THESE ENTITIES BEHAVE LIKE WAVES, CAPABLE OF SPREADING OUT, DIFFRACTING, AND INTERFERING. THIS WAVE NATURE ALLOWS THEM TO SEEMINGLY PASS THROUGH BOTH SLITS AT ONCE.

HOWEVER, THE MOMENT WE ATTEMPT TO DETECT WHICH SLIT A PARTICLE PASSES THROUGH, ITS WAVE-LIKE NATURE COLLAPSES, AND IT BEHAVES LIKE A LOCALIZED PARTICLE, APPEARING AT A SPECIFIC POINT ON THE DETECTION SCREEN. THIS DUALITY IS NOT A FLAW IN OUR UNDERSTANDING BUT A FUNDAMENTAL FEATURE OF THE QUANTUM WORLD. IT'S AS IF THE UNIVERSE HAS DIFFERENT RULES FOR ITS TINIEST CONSTITUENTS, AND THESE RULES ARE DEEPLY INTERTWINED WITH THE ACT OF OBSERVATION ITSELF.

THE ROLE OF THE OBSERVER: MEASUREMENT AND COLLAPSE

ONE OF THE MOST PROFOUND AND DEBATED ASPECTS OF THE QUANTUM PHYSICS SLIT EXPERIMENT IS THE IMPACT OF OBSERVATION ON THE OUTCOME. WHEN THE EXPERIMENT IS SET UP WITHOUT ANY ATTEMPT TO MONITOR WHICH SLIT EACH PARTICLE GOES THROUGH, AN INTERFERENCE PATTERN, INDICATIVE OF WAVE BEHAVIOR, IS OBSERVED. THIS SUGGESTS THAT EACH PARTICLE, IN A SENSE, TRAVELS THROUGH BOTH SLITS SIMULTANEOUSLY, A PHENOMENON KNOWN AS SUPERPOSITION.

HOWEVER, IF DETECTORS ARE PLACED AT THE SLITS TO DETERMINE WHICH PATH A PARTICLE TAKES, THE INTERFERENCE PATTERN DISAPPEARS. INSTEAD, WE OBSERVE THE CLASSICAL RESULT OF TWO DISTINCT BANDS ON THE SCREEN, AS IF WE WERE FIRING MARBLES. THIS PHENOMENON, OFTEN REFERRED TO AS THE "COLLAPSE OF THE WAVE FUNCTION," IMPLIES THAT THE ACT OF MEASUREMENT FORCES THE QUANTUM ENTITY TO CHOOSE A DEFINITE STATE OR PATH. THE OBSERVER, OR RATHER THE MEASUREMENT APPARATUS, SEEMS TO PLAY AN ACTIVE ROLE IN DEFINING THE REALITY OF THE PARTICLE, A CONCEPT THAT DEEPLY CHALLENGES OUR DETERMINISTIC CLASSICAL WORLDVIEW.

SUPERPOSITION AND THE QUANTUM STATE

SUPERPOSITION IS A FUNDAMENTAL PRINCIPLE IN QUANTUM MECHANICS THAT STATES A QUANTUM SYSTEM CAN EXIST IN MULTIPLE STATES OR POSSIBILITIES SIMULTANEOUSLY UNTIL A MEASUREMENT IS MADE. IN THE CONTEXT OF THE DOUBLE-SLIT EXPERIMENT, AN UNOBSERVED ELECTRON IS NOT DEFINITELY GOING THROUGH SLIT A OR SLIT B; IT IS IN A SUPERPOSITION OF GOING THROUGH BOTH. THIS MEANS ITS WAVE FUNCTION, WHICH DESCRIBES ITS PROBABILITY DISTRIBUTION, SPANS BOTH PATHS.

THE WAVE FUNCTION IS A MATHEMATICAL REPRESENTATION OF THE QUANTUM STATE OF A SYSTEM. BEFORE MEASUREMENT, IT CAN BE A COMBINATION OF DIFFERENT POSSIBLE STATES. THE ACT OF MEASUREMENT "COLLAPSES" THIS WAVE FUNCTION INTO A

SINGLE, DEFINITE OUTCOME. THIS COLLAPSE IS NOT A GRADUAL PROCESS BUT AN INSTANTANEOUS TRANSITION, AND IT'S ONE OF THE CENTRAL MYSTERIES OF QUANTUM MECHANICS THAT THE DOUBLE-SLIT EXPERIMENT VIVIDLY DEMONSTRATES.

THE MEASUREMENT PROBLEM

THE "MEASUREMENT PROBLEM" IS A LONG-STANDING PUZZLE IN QUANTUM MECHANICS THAT THE DOUBLE-SLIT EXPERIMENT BRINGS INTO SHARP RELIEF. IT QUESTIONS WHAT CONSTITUTES A "MEASUREMENT" AND WHY AND HOW IT CAUSES THE WAVE FUNCTION TO COLLAPSE. IS IT CONSCIOUSNESS THAT CAUSES THE COLLAPSE? OR IS IT THE INTERACTION WITH A MACROSCOPIC MEASURING DEVICE? THESE ARE QUESTIONS THAT CONTINUE TO BE DEBATED AND HAVE LED TO VARIOUS INTERPRETATIONS OF QUANTUM MECHANICS.

SOME PHYSICISTS PROPOSE THAT THE INTERACTION WITH ANY ENVIRONMENT, NOT JUST A CONSCIOUS OBSERVER, CAN LEAD TO DECOHERENCE, WHICH EFFECTIVELY MIMICS WAVE FUNCTION COLLAPSE. OTHERS HOLD MORE RADICAL VIEWS. REGARDLESS OF THE EXACT MECHANISM, THE DOUBLE-SLIT EXPERIMENT UNEQUIVOCALLY SHOWS THAT THE WAY WE INTERACT WITH A QUANTUM SYSTEM FUNDAMENTALLY ALTERS ITS BEHAVIOR, BLURRING THE LINES BETWEEN THE OBSERVER AND THE OBSERVED.

DIFFERENT INTERPRETATIONS OF QUANTUM MECHANICS

THE PERPLEXING RESULTS OF THE QUANTUM PHYSICS SLIT EXPERIMENT HAVE GIVEN RISE TO NUMEROUS INTERPRETATIONS OF QUANTUM MECHANICS, EACH ATTEMPTING TO MAKE SENSE OF WAVE-PARTICLE DUALITY, SUPERPOSITION, AND THE MEASUREMENT PROBLEM. THESE INTERPRETATIONS, WHILE MATHEMATICALLY EQUIVALENT IN THEIR PREDICTIONS, OFFER VASTLY DIFFERENT PHILOSOPHICAL PICTURES OF REALITY.

THE COPENHAGEN INTERPRETATION

THE COPENHAGEN INTERPRETATION, LARGELY DEVELOPED BY NIELS BOHR AND WERNER HEISENBERG, IS THE MOST WIDELY TAUGHT AND HISTORICALLY SIGNIFICANT INTERPRETATION. IT SUGGESTS THAT QUANTUM SYSTEMS DO NOT POSSESS DEFINITE PROPERTIES UNTIL THEY ARE MEASURED. THE ACT OF MEASUREMENT CAUSES THE WAVE FUNCTION TO COLLAPSE, AND THERE IS NO NEED TO INQUIRE ABOUT WHAT HAPPENS "BEFORE" OR "BETWEEN" MEASUREMENTS. IT EMBRACES THE PROBABILISTIC NATURE OF QUANTUM MECHANICS AND ACCEPTS THAT CERTAIN ASPECTS OF REALITY MAY BE INHERENTLY UNKNOWABLE.

THE MANY-WORLDS INTERPRETATION

PROPOSED BY HUGH EVERETT III, THE MANY-WORLDS INTERPRETATION OFFERS A RADICALLY DIFFERENT PERSPECTIVE. IT SUGGESTS THAT THE WAVE FUNCTION NEVER ACTUALLY COLLAPSES. INSTEAD, EVERY TIME A QUANTUM MEASUREMENT IS MADE, THE UNIVERSE "SPLITS" INTO MULTIPLE PARALLEL UNIVERSES, WITH EACH UNIVERSE REPRESENTING A DIFFERENT POSSIBLE OUTCOME OF THE MEASUREMENT. IN ONE UNIVERSE, THE PARTICLE GOES THROUGH SLIT A; IN ANOTHER, IT GOES THROUGH SLIT B. THIS INTERPRETATION AVOIDS THE CONCEPT OF WAVE FUNCTION COLLAPSE ALTOGETHER BUT AT THE COST OF AN UNFATHOMABLY VAST NUMBER OF PARALLEL REALITIES.

OTHER NOTABLE INTERPRETATIONS

BEYOND COPENHAGEN AND MANY-WORLDS, OTHER INTERPRETATIONS ATTEMPT TO PROVIDE A MORE COMPLETE OR INTUITIVE UNDERSTANDING. THE DE BROGLIE-BOHM THEORY, ALSO KNOWN AS PILOT-WAVE THEORY, SUGGESTS THAT PARTICLES ARE ALWAYS GUIDED BY A "PILOT WAVE," WHICH DETERMINES THEIR TRAJECTORY. THIS INTERPRETATION IS DETERMINISTIC AND AVOIDS THE PROBLEM OF WAVE FUNCTION COLLAPSE BY POSITING HIDDEN VARIABLES. OTHER INTERPRETATIONS, LIKE

CONSISTENT HISTORIES AND QUANTUM BAYESIANISM, FOCUS ON DIFFERENT ASPECTS OF PROBABILITY AND INFORMATION WITHIN THE QUANTUM FRAMEWORK. EACH ATTEMPTS TO GRAPPLE WITH THE PROFOUND IMPLICATIONS OF EXPERIMENTS LIKE THE DOUBLE-SLIT EXPERIMENT, HIGHLIGHTING THE ONGOING QUEST TO COMPREHEND THE FUNDAMENTAL FABRIC OF EXISTENCE.

WHY THE QUANTUM PHYSICS SLIT EXPERIMENT MATTERS

THE QUANTUM PHYSICS SLIT EXPERIMENT IS NOT MERELY AN ACADEMIC CURIOSITY; IT IS A CORNERSTONE OF MODERN PHYSICS THAT HAS HAD PROFOUND IMPLICATIONS FOR OUR UNDERSTANDING OF THE UNIVERSE AND TECHNOLOGICAL ADVANCEMENTS. ITS ABILITY TO DEMONSTRATE FUNDAMENTAL QUANTUM PHENOMENA IN A RELATIVELY STRAIGHTFORWARD SETUP MAKES IT AN INDISPENSABLE TOOL FOR BOTH EDUCATION AND RESEARCH.

FROM TRANSISTORS AND LASERS TO MEDICAL IMAGING AND THE DEVELOPMENT OF QUANTUM COMPUTING, THE PRINCIPLES REVEALED BY THE SLIT EXPERIMENT ARE WOVEN INTO THE FABRIC OF OUR TECHNOLOGICAL SOCIETY. IT FORCES US TO CONFRONT THE LIMITATIONS OF OUR CLASSICAL INTUITION AND EMBRACE A MORE NUANCED AND PERHAPS STRANGER VIEW OF REALITY AT ITS MOST FUNDAMENTAL LEVEL. THE ONGOING EXPLORATION OF ITS IMPLICATIONS CONTINUES TO PUSH THE BOUNDARIES OF SCIENTIFIC KNOWLEDGE AND PHILOSOPHICAL INQUIRY.

IMPACT ON TECHNOLOGY AND SCIENCE

THE PRINCIPLES DEMONSTRATED BY THE QUANTUM PHYSICS SLIT EXPERIMENT ARE NOT CONFINED TO THEORETICAL DISCUSSIONS. THEY ARE THE BEDROCK UPON WHICH MANY MODERN TECHNOLOGIES ARE BUILT. THE UNDERSTANDING OF WAVE-PARTICLE DUALITY, FOR INSTANCE, IS CRUCIAL FOR THE DEVELOPMENT AND OPERATION OF LASERS, WHICH RELY ON THE COHERENT WAVE PROPERTIES OF LIGHT. SIMILARLY, THE BEHAVIOR OF ELECTRONS AS BOTH WAVES AND PARTICLES IS FUNDAMENTAL TO THE FUNCTIONING OF SEMICONDUCTORS, THE BUILDING BLOCKS OF ALL MODERN ELECTRONICS, INCLUDING THE COMPUTER YOU ARE USING TO READ THIS ARTICLE.

FURTHERMORE, THE QUANTUM REALM, AS REVEALED BY THE SLIT EXPERIMENT, IS THE PLAYGROUND FOR EMERGING TECHNOLOGIES LIKE QUANTUM COMPUTING. QUANTUM COMPUTERS LEVERAGE SUPERPOSITION AND ENTANGLEMENT, PHENOMENA THAT ARE INTIMATELY LINKED TO THE BEHAVIOR OBSERVED IN THE DOUBLE-SLIT EXPERIMENT, TO PERFORM CALCULATIONS THAT ARE IMPOSSIBLE FOR CLASSICAL COMPUTERS. THE IMPLICATIONS FOR FIELDS LIKE DRUG DISCOVERY, MATERIALS SCIENCE, AND CRYPTOGRAPHY ARE IMMENSE, ALL STEMMING FROM THE SEEMINGLY SIMPLE ACT OF SENDING PARTICLES THROUGH SLITS.

PHILOSOPHICAL IMPLICATIONS AND THE NATURE OF REALITY

BEYOND ITS SCIENTIFIC AND TECHNOLOGICAL IMPACT, THE QUANTUM PHYSICS SLIT EXPERIMENT HAS PROFOUND PHILOSOPHICAL IMPLICATIONS. IT CHALLENGES OUR DEEPLY INGRAINED NOTIONS OF OBJECTIVITY AND DETERMINISM. IF A PARTICLE'S BEHAVIOR CAN CHANGE SIMPLY BY BEING OBSERVED, WHAT DOES THIS SAY ABOUT THE NATURE OF REALITY ITSELF? IS REALITY OBSERVER-DEPENDENT? THE EXPERIMENT RAISES QUESTIONS ABOUT THE VERY DEFINITION OF EXISTENCE AND THE RELATIONSHIP BETWEEN CONSCIOUSNESS AND THE PHYSICAL WORLD.

IT FORCES US TO RECONSIDER THE IDEA OF AN INDEPENDENT, OBJECTIVE REALITY THAT EXISTS "OUT THERE" REGARDLESS OF WHETHER WE ARE LOOKING AT IT. THE PROBABILISTIC NATURE OF QUANTUM MECHANICS ALSO CONTRASTS SHARPLY WITH THE DETERMINISTIC UNIVERSE OFTEN ENVISIONED BY CLASSICAL PHYSICS. THE QUANTUM PHYSICS SLIT EXPERIMENT SERVES AS A CONSTANT REMINDER THAT OUR EVERYDAY EXPERIENCES, WHILE VALID IN OUR MACROSCOPIC WORLD, MAY NOT ACCURATELY REFLECT THE BIZARRE AND OFTEN COUNTERINTUITIVE RULES THAT GOVERN THE UNIVERSE AT ITS MOST FUNDAMENTAL LEVEL. IT IS A TESTAMENT TO THE ONGOING HUMAN ENDEAVOR TO UNDERSTAND OUR PLACE IN THE COSMOS.

FREQUENTLY ASKED QUESTIONS

Q: WHAT IS THE CORE PHENOMENON DEMONSTRATED BY THE QUANTUM PHYSICS SLIT EXPERIMENT?

A: THE QUANTUM PHYSICS SLIT EXPERIMENT, PARTICULARLY THE DOUBLE-SLIT EXPERIMENT, PRIMARILY DEMONSTRATES WAVE-PARTICLE DUALITY, SHOWING THAT ENTITIES LIKE PHOTONS AND ELECTRONS CAN BEHAVE AS BOTH DISCRETE PARTICLES AND SPREAD-OUT WAVES, EXHIBITING INTERFERENCE PATTERNS CHARACTERISTIC OF WAVES.

A: WHEN A MEASUREMENT IS MADE TO DETERMINE WHICH SLIT A PARTICLE PASSES THROUGH, THE ACT OF OBSERVATION FORCES THE QUANTUM ENTITY OUT OF ITS SUPERPOSITION STATE AND CAUSES ITS WAVE FUNCTION TO COLLAPSE, LEADING IT TO BEHAVE LIKE A LOCALIZED PARTICLE AND THUS DESTROYING THE INTERFERENCE PATTERN.

Q: IS IT ONLY ELECTRONS AND PHOTONS THAT EXHIBIT THIS BEHAVIOR IN THE DOUBLE-SLIT EXPERIMENT?

A: NO, THE WAVE-PARTICLE DUALITY DEMONSTRATED IN THE DOUBLE-SLIT EXPERIMENT HAS BEEN OBSERVED IN A WIDE RANGE OF QUANTUM ENTITIES, INCLUDING ATOMS, MOLECULES, AND EVEN LARGER COMPLEX STRUCTURES, THOUGH THE FEASIBILITY OF OBSERVING SUCH BEHAVIOR DECREASES WITH INCREASING SIZE.

Q: DOES CONSCIOUSNESS PLAY A ROLE IN THE COLLAPSE OF THE WAVE FUNCTION IN THE QUANTUM PHYSICS SLIT EXPERIMENT?

A: THE ROLE OF CONSCIOUSNESS IN WAVE FUNCTION COLLAPSE IS A HIGHLY DEBATED TOPIC. MOST INTERPRETATIONS OF QUANTUM MECHANICS SUGGEST THAT IT IS THE INTERACTION WITH A MEASURING APPARATUS, RATHER THAN CONSCIOUSNESS ITSELF, THAT CAUSES THE COLLAPSE, THOUGH SOME INTERPRETATIONS EXPLORE THE POTENTIAL INVOLVEMENT OF CONSCIOUSNESS.

Q: WHAT IS THE SIGNIFICANCE OF THE INTERFERENCE PATTERN OBSERVED IN THE QUANTUM PHYSICS SLIT EXPERIMENT?

A: THE INTERFERENCE PATTERN IS CRUCIAL BECAUSE IT IS A SIGNATURE OF WAVE BEHAVIOR. ITS APPEARANCE WHEN PARTICLES ARE SENT THROUGH THE SLITS INDIVIDUALLY IMPLIES THAT EACH PARTICLE, IN SOME SENSE, TRAVERSES BOTH SLITS SIMULTANEOUSLY AND INTERFERES WITH ITSELF, A PHENOMENON ONLY POSSIBLE FOR WAVES.

Q: HOW DOES THE DOUBLE-SLIT EXPERIMENT RELATE TO QUANTUM SUPERPOSITION?

A: THE DOUBLE-SLIT EXPERIMENT IS A PRIME EXAMPLE OF QUANTUM SUPERPOSITION. BEFORE MEASUREMENT, THE QUANTUM PARTICLE EXISTS IN A SUPERPOSITION OF STATES, MEANING IT IS SIMULTANEOUSLY IN ALL POSSIBLE PATHS OR CONFIGURATIONS, SUCH AS GOING THROUGH BOTH SLITS AT ONCE.

Q: WHAT ARE SOME OF THE MAIN INTERPRETATIONS OF THE QUANTUM PHYSICS SLIT EXPERIMENT'S RESULTS?

A: MAJOR INTERPRETATIONS INCLUDE THE COPENHAGEN INTERPRETATION (WAVE FUNCTION COLLAPSE UPON MEASUREMENT), THE MANY-WORLDS INTERPRETATION (UNIVERSE SPLITS FOR EACH OUTCOME), AND THE DE BROGLIE-BOHM THEORY (PILOT-WAVE

GUIDING PARTICLES).

Q: CAN THE DOUBLE-SLIT EXPERIMENT BE PERFORMED WITH MACROSCOPIC OBJECTS?

A: WHILE THE FUNDAMENTAL PRINCIPLES OF WAVE BEHAVIOR APPLY TO ALL MATTER, THE WAVELENGTHS OF MACROSCOPIC OBJECTS ARE SO INFINITESIMALLY SMALL THAT THEIR WAVE-LIKE PROPERTIES ARE PRACTICALLY UNDETECTABLE, MAKING INTERFERENCE PATTERNS IN THE DOUBLE-SLIT EXPERIMENT UNOBSERVABLE FOR EVERYDAY OBJECTS.
