The combination of these particle sizes, often depicted on a soil texture triangle, dictates many of the soil's physical behaviors. For instance, a sandy loam soil, with a good balance of sand and loam, might offer excellent drainage while still retaining enough moisture for plant growth. Conversely, a clay soil, with a high clay content, might be very fertile and hold ample water but can become waterlogged and difficult to work if not managed properly. Understanding soil texture is the first step in predicting how a soil will behave and how to best manage it.

Good soil structure creates a network of pores, which are critical for water infiltration, drainage, and air circulation. This pore space is where plants get their oxygen, water moves, and roots can easily penetrate.

Different types of soil structure exist, such as granular, blocky, prismatic, and platy. The sum of these potentials determines the total soil water potential. Plants can only extract water when its potential in the soil is higher than its potential within the plant roots. When matric potential becomes very low (i.e., very negative), water is held too tightly for most plants to access.

Water Movement in Soil

Water moves through the soil in response to differences in water potential. This movement can occur in liquid form or as vapor. The primary mechanisms for liquid water movement are infiltration (water entering the soil surface) and percolation (water moving downward through the soil profile). The rate at which water moves is heavily influenced by soil texture, structure, and the presence of macropores (large pores). Coarse-textured soils, with larger pores, generally have higher infiltration and percolation rates than fine-textured soils, which can become saturated and impede water movement.

Darcy's Law is a fundamental principle used to describe and quantify water flow through

porous media like soil. It states that the flow rate of water is proportional to the hydraulic gradient (the change in hydraulic head over distance) and inversely proportional to the flow path length. This can stress plants, inhibit root growth, and lead to the accumulation of toxic byproducts from anaerobic respiration.

Compaction is another major enemy of good soil aeration. When soil is compacted, the pore spaces are reduced, making it harder for air to move in and out. This is why maintaining good soil structure is so important, not just for water movement but also for gas exchange. The presence of healthy organic matter also contributes to better aeration by promoting the formation of stable aggregates.
