Rotational Kinematics

Angular Displacement and Radians

To describe rotational motion, we need new variables. The rotational equivalent of linear displacement is angular displacement, often denoted by the Greek letter theta (θ). Instead of measuring distance in meters, we measure the angle an object rotates through. While angles can be measured in degrees, in physics, we almost always use radians. A radian is defined as the angle subtended at the center of a circle by an arc whose length is equal to the radius of the circle. The relationship is fundamental: arc length (s) equals radius (r) times angular displacement in radians (θ),

so $s = r\theta$. This conversion is crucial because the formulas for rotational kinematics are derived using radians.

Think of it this way: if you walk one step forward, that's a linear displacement. If you turn your head by a certain angle, that's an angular displacement. The key is that radians provide a direct relationship between the angle and the arc length, which is essential for consistency in our physics equations. A full circle is 360° , which is equivalent to 2π radians. Half a circle is 180° , or π radians.

Angular Velocity

Angular velocity, represented by the Greek letter ω (ω), is the rate of change of angular displacement. It tells us how fast an object is rotating. Just as linear velocity (v) is displacement (Δx) divided by time (Δt), angular velocity (ω) is angular displacement ($\Delta \theta$) divided by time (Δt). The units for angular velocity are typically radians per second (rad/s). A positive angular velocity usually indicates counter-clockwise rotation, while a negative one indicates clockwise rotation. Average angular velocity is $\omega_{\text{avg}} = \frac{\Delta \theta}{\Delta t}$, and instantaneous angular velocity is the limit as Δt approaches zero.

Imagine two points on a spinning wheel. The point farther from the center travels a greater linear distance in the same amount of time, but both points have the same angular velocity. This is a key difference between linear and rotational motion: all points on a rigid rotating object have the same angular velocity, but their linear speeds vary with their distance from the axis of rotation.

Angular Acceleration

Angular acceleration, denoted by the Greek letter α (α), is the rate of change of angular velocity. It tells us how quickly the rotational speed is changing. Similar to linear acceleration (a) being the change in velocity (Δv) over time (Δt), angular acceleration (α) is the change in angular velocity ($\Delta \omega$) over time (Δt). Its units are radians per second squared (rad/s²). If an object is speeding up its rotation, it has an angular acceleration in the same direction as its angular velocity. If it's slowing down, the angular acceleration is in the opposite direction.

Rotational Kinematic Equations

When an object experiences constant angular acceleration, we can use a set of kinematic equations that are remarkably similar to the linear kinematic equations you've already learned. They are direct translations of the linear kinematic equations, with linear displacement replaced by angular displacement, linear velocity by angular velocity, and linear acceleration by angular acceleration.

Rotational Dynamics: Torque and Moment of Inertia

Torque

Just as a net force causes linear acceleration, a net torque causes angular acceleration. Torque (τ) is the rotational equivalent of force. It's a twisting or turning effect. Torque depends on three factors: the magnitude of the applied force (F), the distance from the pivot point (axis of rotation) to where the force is applied (lever arm, r), and the angle (ϕ) between the force vector and the lever arm vector. Moment of Inertia

The moment of inertia (I) is the rotational equivalent of mass. It represents an object's resistance to changes in its rotational motion. Unlike mass, which is a scalar quantity, the moment of inertia depends not only on the object's mass but also on how that mass is distributed relative to the axis of rotation. Objects with their mass concentrated farther from the axis of rotation have a larger moment of inertia and are harder to get spinning or to stop spinning.

For a system of point masses, the moment of inertia is the sum of the mass of each particle multiplied by the square of its distance from the axis of rotation: $I = \sum m_i r_i^2$. For continuous objects, we use integration to find the moment of inertia. Different shapes have different formulas for their moment of inertia. For example, a solid cylinder rotating about its central axis has $I = \frac{1}{2}MR^2$, while a thin rod rotating about its center has $I = \frac{1}{12}ML^2$. Understanding the moment of inertia is crucial for applying Newton's second law for rotation.

Newton's Second Law for Rotation

Newton's second law for rotation states that the net torque acting on an object is equal to the product of its moment of inertia and its angular acceleration: $\sum \tau_{\text{net}} = I\alpha$. An object can have both translational and rotational kinetic energy simultaneously. For instance, a rolling ball has both types of kinetic energy. The total kinetic energy of such an object would be the sum of its translational and rotational kinetic energies: $K_{\text{total}} = K_{\text{trans}} + K_{\text{rot}} = \frac{1}{2}mv^2 + \frac{1}{2}I\omega^2$. This concept is vital when analyzing systems where energy is conserved, as it allows us to account for energy associated with spinning motion.
