## Electric Charge

## Electric Current

$\Omega = 1 \text{ J}/(\text{A} \cdot \text{s} \cdot \text{A}) = 1 \text{ J}/(\text{A}^2 \cdot \text{s})$ .

Finally, substituting  $\text{J} = \text{kg} \cdot \text{m}^2/\text{s}^2$ :

$\Omega = (1 \text{ kg} \cdot \text{m}^2/\text{s}^2) / (\text{A}^2 \cdot \text{s}) = 1 \text{ kg} \cdot \text{m}^2 / (\text{A}^2 \cdot \text{s}^3)$ .
