- **ENTER REQUIRED INFORMATION:** YOU WILL TYPICALLY NEED TO PROVIDE THE PSYCHOLOGIST’S FULL NAME, AND SOMETIMES ADDITIONAL INFORMATION SUCH AS THEIR LICENSE NUMBER OR LOCATION.
- **REVIEW THE RESULTS:** THE SEARCH WILL YIELD RESULTS SHOWING THE PSYCHOLOGIST’S LICENSE STATUS, EXPIRATION DATE, AND ANY DISCIPLINARY ACTIONS, IF APPLICABLE.

HAVING ACCESS TO THIS INFORMATION ENHANCES TRANSPARENCY AND ALLOWS CONSUMERS TO MAKE INFORMED DECISIONS REGARDING THEIR MENTAL HEALTH CARE PROVIDERS.

CONSEQUENCES OF PRACTICING WITHOUT A LICENSE
