ACCORDING TO THIS VIEW, UNRESOLVED PSYCHOLOGICAL ISSUES CAN MANIFEST AS CRIMINAL BEHAVIOR IN ADULTHOOD, HIGHLIGHTING THE IMPORTANCE OF EARLY INTERVENTION.

BEHAVIORAL THEORIES

BEHAVIORAL THEORIES FOCUS ON THE IDEA THAT CRIMINAL BEHAVIOR IS LEARNED THROUGH INTERACTIONS WITH THE ENVIRONMENT. THIS LEARNING CAN OCCUR THROUGH DIRECT REINFORCEMENT OR BY OBSERVING OTHERS. STRAIN THEORY

STRAIN THEORY POSITS THAT SOCIETAL PRESSURES AND THE INABILITY TO ACHIEVE CULTURALLY ACCEPTED GOALS CAN LEAD INDIVIDUALS TO COMMIT CRIMES. WHEN LEGITIMATE PATHWAYS TO SUCCESS ARE BLOCKED, INDIVIDUALS MAY RESORT TO UNLAWFUL METHODS TO ACHIEVE THEIR GOALS, THUS HIGHLIGHTING THE IMPACT OF SOCIOECONOMIC FACTORS ON CRIMINAL BEHAVIOR.

PSYCHOLOGICAL PROFILING OF CRIMINALS

PSYCHOLOGICAL PROFILING IS A CRITICAL TOOL USED IN THE FIELD OF CRIME PSYCHOLOGY TO UNDERSTAND AND PREDICT CRIMINAL BEHAVIOR. MENTAL HEALTH AND CRIME
