## UNDERSTANDING DIVIDED ATTENTION

## IMPACT ON LEARNING

DIVIDED ATTENTION CAN SEVERELY IMPACT LEARNING OUTCOMES. WHEN STUDENTS TRY TO MULTITASK, THEY MAY MISS CRITICAL INFORMATION AND STRUGGLE TO GRASP COMPLEX CONCEPTS.
