UNDERSTANDING IRB PSYCHOLOGY DEFINITION

RESPECT FOR PERSONS ENTAILS RECOGNIZING THE AUTONOMY OF PARTICIPANTS AND ENSURING THEY PROVIDE INFORMED CONSENT. BENEFICENCE REQUIRES RESEARCHERS TO ACT IN THE BEST INTEREST OF PARTICIPANTS, WHILE JUSTICE INVOLVES EQUITABLE DISTRIBUTION OF THE RESEARCH BURDENS AND BENEFITS.

THE ROLE OF INSTITUTIONAL REVIEW BOARDS

INSTITUTIONAL REVIEW BOARDS PLAY A PIVOTAL ROLE IN OVERSEEING RESEARCH INVOLVING HUMAN SUBJECTS. THEIR RESPONSIBILITIES ARE MULTIFACETED AND CRITICAL TO MAINTAINING ETHICAL STANDARDS IN PSYCHOLOGICAL RESEARCH.

PRIMARY FUNCTIONS OF IRBS

THE PRIMARY FUNCTIONS OF IRBS INCLUDE:

- REVIEWING RESEARCH PROPOSALS TO ENSURE ETHICAL STANDARDS ARE MET.
- MONITORING ONGOING RESEARCH TO ENSURE COMPLIANCE WITH APPROVED PROTOCOLS.

IRBS ARE COMPOSED OF DIVERSE MEMBERS, INCLUDING SCIENTISTS, NON-SCIENTISTS, AND COMMUNITY REPRESENTATIVES, WHICH ALLOWS FOR A COMPREHENSIVE EVALUATION OF RESEARCH PROPOSALS FROM MULTIPLE PERSPECTIVES.

TYPES OF IRB REVIEWS

IRBS CONDUCT DIFFERENT TYPES OF REVIEWS DEPENDING ON THE NATURE OF THE RESEARCH:

- **EXEMPT REVIEW:** RESEARCH THAT POSES MINIMAL RISK MAY QUALIFY FOR AN EXEMPT REVIEW, ALLOWING FOR A STREAMLINED APPROVAL PROCESS.
- **EXPEDITED REVIEW:** STUDIES INVOLVING NO MORE THAN MINIMAL RISK MAY UNDERGO EXPEDITED REVIEW, WHICH IS FASTER THAN A FULL BOARD REVIEW.
- **FULL BOARD REVIEW:** RESEARCH THAT INVOLVES GREATER THAN MINIMAL RISK TYPICALLY REQUIRES A FULL BOARD REVIEW, WHERE ALL MEMBERS ASSESS THE PROPOSAL IN DETAIL.

UNDERSTANDING THESE REVIEW TYPES HELPS RESEARCHERS NAVIGATE THE IRB PROCESS EFFECTIVELY.

ETHICAL CONSIDERATIONS IN PSYCHOLOGICAL RESEARCH

ETHICAL CONSIDERATIONS ARE AT THE HEART OF THE IRB PSYCHOLOGY DEFINITION. RESEARCHERS MUST BE ACUTELY AWARE OF THE ETHICAL IMPLICATIONS OF THEIR WORK, PARTICULARLY WHEN INVOLVING VULNERABLE POPULATIONS.

INFORMED CONSENT

VULNERABLE POPULATIONS

SUBMISSION OF RESEARCH PROPOSALS

APPROVAL AND MONITORING

ROLES AND RESPONSIBILITIES OF IRB MEMBERS

COMPOSITION OF IRB

AN EFFECTIVE IRB TYPICALLY INCLUDES:

- SCIENTISTS WITH EXPERTISE IN RELEVANT RESEARCH AREAS.
- NON-SCIENTIFIC MEMBERS WHO PROVIDE A DIFFERENT PERSPECTIVE.
- COMMUNITY REPRESENTATIVES WHO CAN VOICE THE CONCERNS OF THE POPULATION BEING STUDIED.

RESPONSIBILITIES OF IRB MEMBERS

IRB MEMBERS ARE RESPONSIBLE FOR:

- REVIEWING RESEARCH PROPOSALS CAREFULLY AND IMPARTIALLY.
- IDENTIFYING POTENTIAL ETHICAL ISSUES AND SUGGESTING IMPROVEMENTS.
- ENSURING COMPLIANCE WITH INSTITUTIONAL, FEDERAL, AND ETHICAL GUIDELINES.
- PARTICIPATING IN ONGOING EDUCATION ABOUT ETHICAL RESEARCH PRACTICES.

EACH MEMBER'S CONTRIBUTION IS VITAL FOR UPHOLDING THE ETHICAL STANDARDS OF PSYCHOLOGICAL RESEARCH.

TYPES OF RESEARCH REQUIRING IRB APPROVAL

SEVERAL TYPES OF RESEARCH NECESSITATE IRB APPROVAL TO ENSURE ETHICAL COMPLIANCE AND PARTICIPANT PROTECTION.

BEHAVIORAL RESEARCH

BEHAVIORAL RESEARCH, WHICH OFTEN INVOLVES INTERACTIONS WITH PARTICIPANTS OR OBSERVATIONAL STUDIES, TYPICALLY REQUIRES IRB OVERSIGHT DUE TO POTENTIAL RISKS ASSOCIATED WITH PARTICIPANT INVOLVEMENT.

CLINICAL TRIALS

CLINICAL TRIALS, ESPECIALLY THOSE TESTING NEW INTERVENTIONS OR THERAPIES, ARE SCRUTINIZED BY IRBS TO ENSURE PARTICIPANT SAFETY AND INFORMED CONSENT PROCESSES ARE RIGOROUSLY FOLLOWED.

SURVEYS AND QUESTIONNAIRES

EVEN RESEARCH INVOLVING SURVEYS AND QUESTIONNAIRES CAN REQUIRE IRB REVIEW, PARTICULARLY IF SENSITIVE INFORMATION IS BEING COLLECTED OR IF THE RESEARCH TARGETS VULNERABLE POPULATIONS.

CONSEQUENCES OF NON-COMPLIANCE

FAILING TO COMPLY WITH IRB REGULATIONS CAN HAVE SERIOUS REPERCUSSIONS FOR RESEARCHERS AND INSTITUTIONS.

LEGAL AND ETHICAL IMPLICATIONS

LEGAL IMPLICATIONS MAY INCLUDE LAWSUITS OR SANCTIONS AGAINST RESEARCHERS OR INSTITUTIONS. ETHICALLY, NON-COMPLIANCE UNDERMINES THE INTEGRITY OF THE RESEARCH AND CAN LEAD TO HARM FOR PARTICIPANTS.

IMPACT ON RESEARCH FUNDING

NON-COMPLIANCE CAN ALSO JEOPARDIZE RESEARCH FUNDING, AS MANY FUNDING AGENCIES REQUIRE IRB APPROVAL AS A CONDITION FOR FINANCIAL SUPPORT.

REPUTATION DAMAGE

ADDITIONALLY, THE REPUTATION OF THE RESEARCHERS AND THEIR INSTITUTIONS MAY SUFFER, LEADING TO A LOSS OF TRUST WITHIN THE ACADEMIC COMMUNITY AND THE PUBLIC.
