WHAT IS FORENSIC PSYCHOLOGY?

- **TREATMENT PROVIDERS:** THEY MAY WORK IN CORRECTIONAL SETTINGS TO PROVIDE THERAPY AND REHABILITATION SERVICES TO OFFENDERS.

IMPORTANCE OF FORENSIC PSYCHOLOGY IN THE LEGAL SYSTEM

MANY INSTITUTIONS REQUIRE GRE (GRADUATE RECORD EXAMINATION) SCORES AS PART OF THE APPLICATION PROCESS. A STRONG GRE SCORE CAN STRENGTHEN YOUR APPLICATION AND DEMONSTRATE YOUR READINESS FOR ADVANCED STUDY.

LETTERS OF RECOMMENDATION AND PERSONAL STATEMENT

APPLICANTS ARE TYPICALLY REQUIRED TO SUBMIT LETTERS OF RECOMMENDATION FROM ACADEMIC OR PROFESSIONAL REFERENCES WHO CAN SPEAK TO THEIR QUALIFICATIONS AND POTENTIAL FOR SUCCESS IN THE FIELD. ADDITIONALLY, A PERSONAL STATEMENT OUTLINING YOUR MOTIVATIONS, EXPERIENCES, AND CAREER GOALS IS ESSENTIAL. THIS STATEMENT ALLOWS YOU TO CONVEY YOUR PASSION FOR FORENSIC PSYCHOLOGY AND YOUR COMMITMENT TO THE FIELD.

CAREER OPPORTUNITIES
