UNDERSTANDING PROSPECTIVE MEMORY

BOTH TYPES ARE CRUCIAL FOR EFFECTIVE TIME MANAGEMENT AND PERSONAL ORGANIZATION.

TYPES OF PROSPECTIVE MEMORY
