UNDERSTANDING VICTIMHOOD

DEFINITION OF VICTIMHOOD

RECOGNIZING THESE REACTIONS IS ESSENTIAL FOR UNDERSTANDING THE LONG-TERM EFFECTS OF TRAUMA ON VICTIMS AND THE NEED FOR APPROPRIATE INTERVENTIONS.

BEHAVIORAL RESPONSES OF VICTIMS

COPING MECHANISMS

THE IMPACT OF VICTIM BLAMING CAN BE PROFOUND, AS VICTIMS MAY INTERNALIZE NEGATIVE SOCIETAL ATTITUDES, FURTHER COMPLICATING THEIR HEALING PROCESS.

SOCIETAL PERCEPTIONS OF VICTIMS

MEDIA REPRESENTATION
