DEFINITION OF STIMULUS DISCRIMINATION

THIS DIFFERENTIATION ALLOWS FOR MORE NUANCED REACTIONS AND BEHAVIORS BASED ON VARYING CIRCUMSTANCES. THE ABILITY TO DISCRIMINATE BETWEEN STIMULI IS ESSENTIAL FOR SURVIVAL, AS IT HELPS ORGANISMS AVOID DANGER AND SEEK OUT BENEFICIAL OPPORTUNITIES.
