UNDERSTANDING TED BUNDY'S EARLY LIFE

TED BUNDY WAS BORN ON NOVEMBER 24, 1946, IN BURLINGTON, VERMONT, TO AN UNWED MOTHER. HIS EARLY LIFE WAS MARKED BY INSTABILITY AND CONFUSION REGARDING HIS IDENTITY. INDIVIDUALS WITH THIS DISORDER OFTEN ENGAGE IN PATTERNS OF BEHAVIOR THAT VIOLATE SOCIETAL NORMS AND THE RIGHTS OF OTHERS. BUNDY'S ACTIONS, WHICH INCLUDED DECEIT, AGGRESSION, AND A BLATANT DISREGARD FOR HUMAN LIFE, ALIGN WITH THIS DIAGNOSIS.
