Backed by the JCS, the national security adviser, and key members of Congress, Brown persuaded Carter to increase the defense budget for the last two years of his term. The secretary championed the development and production of new weapons such as stealth aircraft, precision-guided bombs, and cruise missiles. These and other initiatives laid a solid foundation for the much-acclaimed Ronald Reagan defense revolution that actually began under Carter.
