This clause establishes a separation between church and state, preventing government establishment of a religion and protecting the individual's right to practice their chosen religion (or no religion) freely. This doesn't mean religion is banned from public life, but rather that the government cannot favor one religion over another or impose religious beliefs on its citizens. Landmark Supreme Court cases like *Engel v. Vitale* (1962) and *Abington School District v. Schempp* (1963) further clarified this principle.

1.2 Freedom of Speech: The Marketplace of Ideas
